1. REQUIREMENTS

The United Nations High Commissioner for Refugees (UNHCR), National Office in Moldova invites qualified service providers to make a firm offer for the establishment of a Frame Agreement for the provision of Communication Services (referred to hereinafter as "Services").

UNHCR may award a Frame Agreement with initial duration of 1 (one) years, potentially extendable for a further period of 1 (one) year. The successful bidders will be requested to maintain their quoted price model for the duration of the Frame Agreement(s).
